NOVEMBER 3 ELECTION REMINDERS:

Absentee ballots can be requested by going to <https://myvote.wi.gov/> or at the village hall. A valid photo i.d. is required for both options. Everyone qualifies for absentee voting.

Return Absentee ballots before November 3 by 8:00 p.m. Drop off box in front of village hall available too. Check website for updates.

In person voting begins October 20. Vote during regular office hours M-F 9-3:30. A valid photo is required.

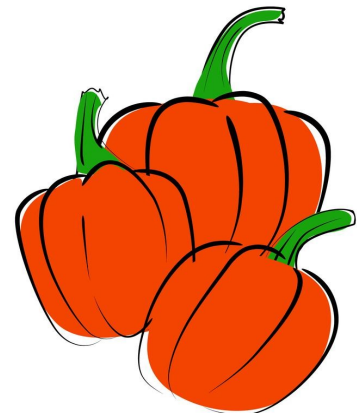
The Compost site closes on November 18, 2020.

Wintertime Reminders:

- Property owners and occupants are responsible for removing snow and ice from sidewalks within 24 hours after the snowfall ceases. (Village ordinance 12.07)
- The village encourages residents living near a fire hydrant to help us keep the hydrants clear of snow, which will allow faster access to the fire department in the event of a fire.
- When ice has formed and cannot be immediately removed, residents should use salt, sawdust or sand to cover the area.
- Removing snow from private property and depositing on sidewalks, streets or other public places is prohibited.
- Sand barrels are available on Verrill and School St., behind the Village Hall and Cherry and West Cedar.
