A note from the Utilities Director:

Spring is upon us, and I am eager for the warm weather. With that in mind, I would like to take a moment to share some information about road right-of-way's with you. A right-of-way is a term for the strip of land that is required for the placement of roads, shoulders, sidewalks, and utilities (gas, electric, water, sewer, and communication). The width of road right-of-way's vary from street to street, and can even vary as you travel down a given street. The important part to remember is that in most all cases, the right-of-way is significantly wider than the width of the roadway itself.

Section 12.04 and 12.05 of our local municipal code discuss the rules and regulations regarding activities in the right-of-way areas. If you are planning a project in the right-of-way area (landscaping, plantings, etc.) there is a permit that is required. Please contact our building inspector to apply for a permit. Please also feel free to contact me if you have questions about right-of-way locations or require information on what is allowed within this area.

Whiting Walking and Biking Trails

Feeding Deer

We have received several complaints of residents feeding deer on their property. The Wisconsin DNR has designated certain counties as having the presence of CWD (Chronic Wasting Disease). Portage county is one of those counties where DNR regulation NR 19.60 applies:

Wisconsin Deer Feeding and Wisconsin Wildlife Feeding Regulations:

Feeding wild animals for non-hunting purposes is prohibited. No person may place, deposit, or allow the placement of any material to feed or attract wild animals for non-hunting purposes including recreational and supplemental feeding, except as allowed below for birds and small mammals.

Feeding Birds and Small Mammals: Materials may be placed solely for the purpose of attracting and feeding wild birds and small mammals if:

- placed in bird feeding devices and the structures are at a sufficient height or design to prevent access by deer.
- The structures and devices are within 50 yards of a dwelling devoted to human occupancy
- When deer, bear or elk are found to be utilizing bird feeding devices or structures the devices or structures shall be enclosed or elevated higher to prevent access by deer, etc.
