We welcome Spring again after a very non-typical winter in Wisconsin. Let's hope the nice weather continues as we head into summer. There are a few items of importance on the following pages, which can also be found on our website.

EXCESSIVE SPEED ON MCDILL/HH

We have heard concerns about excessive speeds on McDill/HH from numerous residents. Since this road is a county road the Village of Whiting is limited in what we can directly do to reduce speeds. We have installed speed monitoring signs and speed limit signs. Beyond that the village doesn't have authority to do more.

The best thing to do if you have concerns is to contact the Portage County Sherriff's office and your Portage County Supervisor.

EMERALD ASH BORER AWARENESS

As you may be aware, emerald ash borer (EAB) is an invasive species from Asia that was discovered in the United States in 2002. Since then, EAB has spread to 30 states, including Wisconsin and has been responsible for the death of tens of millions of ash trees. In February, EAB was confirmed to be present in Whiting and has infected many, if not all of the untreated ash trees present within our community.

EAB infections are lethal to ash trees and infected trees will die if left untreated. Unfortunately, many of our ash trees will succumb to EAB within the next few growing seasons. However, EAB infections can be prevented with the utilization of specific pesticides used to eliminate beetle larvae present in the tree before they cause serious damage. These pesticides can be applied by a certified arborist and have the potential to save trees that are otherwise defenseless against EAB.

Infected trees will either need to be treated to prevent serious damage from infection or can be left untreated but will require removal at some point in the near future. Proactive removal or treatment is recommended.

Please note: Some tree removal companies are required to remove and destroy infected ash wood offsite and may not be able to leave the cut ash wood on your property for you to use later as firewood.
